LIFETIME GUARANTEE

WITH 25-YEAR COST-OF-REPLACEMENT WARRANTY

LIFETIME GUARANTEE: Endot "NSF" plastic pipe is guaranteed for an individual purchasers' lifetime against rot, rust, and electrolytic corrosion and to be free from defects in materials and workmanship. Endot Industries, Inc. hereby limits its responsibility to the replacement of any Endot "NSF" pipe acknowledged to be defective. For corporate or other non-individual purchasers, this guarantee is for 50 years from date of pipe purchase.

COST OF REPLACEMENT WARRANTY FOR 25 YEARS: If Endot "NSF" pipe or tubing (installed in accord with normally accepted installation procedures and used within recommended pressure ratings) fails within 25 years from date of purchase, Endot Industries, Inc. will supply to the purchaser the following:

FOR PUMP PIPE:

1. An equal quantity of Endot "NSF" pipe to replace that proven to be defective, free of charge and freight prepaid.
2. Payment for all reasonable direct labor charges incurred on the site in removing the defective drop pipe and replacing with new Endot "NSF" pipe plus \$10.00 to cover operation of equipment and from job site.
3. Payment for replacement or repairs of the pump if it is lost or damaged as a result of proven defect or separation of the pipe itself, on the following basis:

REPLACEMENT: Based on lowest cost of equivalent pump, reduced by an amount proportioned by the length of service of the replaced pump.

REPAIRS: Actual repair cost up to \$25.00 maximum on any one repair.

FOR DISTRIBUTION LINES:

1. An equal quantity of Endot "NSF" pipe or tubing to replace that proven defective, free of charge and freight prepaid.
2. Payment for reasonable direct labor charges up to \$1.00 per linear foot, incurred on the site in the removal of the defective distribution pipe and the replacement with new Endot "NSF" pipe.

EXCLUSIONS: This warranty does not cover pump replacement or repairs from causes other than proven pipe defect, such as, but not limited to, breakage of fittings, joint separation, unworkmanlike or improper pump installation or removal, incorrect working pressure or use beyond design specifications. Use of sealing compounds, pipe dope and/or detergent type lubricants during installation void this warranty.

This warranty applies 100% during the first five years from date of purchase and claims during the 6th through 25th years shall be reduced at a rate of 5% per annum.

The warranty card must be correctly and completely filled out at the time of installation and returned to Endot Industries, Inc. within 30 days or the above warranty and guarantee is void. The warranty and guarantee may not be modified except in writing and are for the sole benefit of the purchaser and shall not create any rights against Endot Industries, Inc. in any other person and shall constitute the sole and exclusive remedy of any purchaser of Endot "NSF" including, but not limited to, any warranty of merchantability of fitness, and all other obligations or liabilities of Endot Industries, Inc. who shall also not be liable for special or consequential damages, or for damages resulting from negligence of others, misuse, casualties, acts of God, or other matters beyond our control. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
